SUSTAIN.... USEPA is pleased to offer a one-day workshop on the System for Urban Stormwater Treatment and Analysis Integration (SUSTAIN). SUSTAIN is a decision support system for placement of BMPs at strategic locations in urban watersheds based on cost and effectiveness. It is developed by Tetra Tech, Inc. under contract with USEPA. SUSTAIN, an ArcGIS-based evaluation and decision-support framework, is designed for analysis and determination of Total Maximum Daily Load (TMDL), urban watershed planning, and source water protection programs. A poster file about SUSTAIN is attached for your information. SUSTAIN is scheduled to be released to a targeted beta testers in February 2009 and a full release is planned in the summer. This workshop is free of charge and will be held in the DuPage County Administration Building, Wheaton, IL on February 12, 2009. Because of space limitations, we would like you to pre-register using the attached registration form.
