

What is a CPESC?



A CPESC is a recognized specialist in soil erosion and sediment control. The certification program, sponsored by the Soil and Water Conservation Society and the International Erosion Control Association, in cooperation with the American Society of Agronomy, provides the public with evidence of professional qualifications. This designation is given to specialists who have met established standards of expertise, experience and knowledge.

- ◆ The Review Course is open to everyone.
- ◆ The CPESC application process must be completed to be eligible to take exam. A CPESC acceptance letter is required to take the exam.
- ◆ Visit www.cpesc.org for information on the application process. Keep in mind that it takes at least 45 days for applications to be reviewed and accepted. It is strongly encouraged that any one seeking to sit for the exam begin their application process ASAP.
- ◆ Minimum requirements for CPESC applicants include meeting at least one of the following requirements:
 - ◆ Earn a BS degree or higher plus three years of professional level experience in the soil erosion and sediment control profession - college transcripts are required.
 - ◆ Complete seven years or more of professional level experience in the erosion and sediment control profession.
- ◆ It is not required that you sit for the exam on November 19. Examinations are to be completed within ONE YEAR of taking the review course.

LOCATION/DIRECTIONS

The Review Course and Exam will be held at DePaul University Naperville Campus, 150 West Warrenville Road, Building 200 in Naperville, IL. The DePaul University Naperville Campus is located on Warrenville Road just north of I-88 and east of Winfield Road. Exit I-88 at Winfield Road north to Warrenville Road and head east.

REGISTRATION INFORMATION

- ◆ The registration fees for the review course, exam and course manual are separate from the CPESC application fee (see www.cpesc.org for more information on the official CPESC exam application process).
- ◆ Lunch and snacks are included as a part of registration fee.
- ◆ A CPESC Exam Review Course manual is required. Manuals can be purchased directly from CPESC for \$75.
- ◆ Space is limited so please register at your earliest convenience (CPESC acceptance letter is not required to participate in the review course).
